Do you have a skillset, expertise or a piece of knowledge / research that you want to share with the sector? We are offering fees of $\pounds 600$ to develop shareable resources or guides that can be used now and in the future.

We are calling for artists who can generate resources that can be shared with other artists. At g39 we are big believers in freely sharing knowledge and information as a way of strengthening the community.

Resource topics could be anything that you think would be beneficial to artists at any stage of their development. You might compile a guide on: socially engaged practice, bilingual working, financial wellbeing, peer networks, practice and protest, gallery technician knowhow, self-employment, rethinking success, application writing, sustainability - we are open to ideas. As a collection we hope the resources might indicate how practice can positively influence wellbeing and society.

Your resource will be hosted or signposted on the warp | g39 websites. Its format should enable it to be archived, retrieved and freely available for use.

Please ensure that by producing and publishing your resource you are not putting yourself, the public or g39 at risk by encouraging the spread of Coronavirus (for example by encouraging groups to gather).

There is a budget of \pounds 600 for the commission. Up to 90% (\pounds 540) of this can be released in advance of the commission. We subscribe to the <u>Paying Artists</u> guidelines (g39 is a 'Category A' organisation in the Framework). This budget should cover your fee and production / publishing costs. We want to see proposals that are ambitious and creative, while ensuring a level of fair pay for the commissioned artist.

You will be supported by the g39 team to develop the resource. This includes technical advice, professional development and promotion of your work and you as a commissioned artist. All contact between you and us will take place online, ensuring that everyone is encouraged to stay home and keep safe.

Resources will be available no later than November 2020.

Who is this opportunity for?

We welcome applications from people irrespective of disability, gender, sexual orientation, marital status, family responsibility, age, race, ethnic origin, nationality (subject to issue of work permit where required), trade union membership and activity, political or religious beliefs.

We are committed to supporting more applications and commissions from artists whose background and/or identity is under-represented in the programme, in our resources and our staff and board of g39. This includes, but is not limited to, artists from Black, Asian and ethnically diverse backgrounds, artists from lower socioeconomic backgrounds, d/Deaf artists, neurodiverse artists, artists with disabilities or long-term health difficulties and artists with LGBTQIA+ identities.

This information is gathered so that we can monitor what we do, but it is separate and anonymous. If you would like us to consider your background or identity during the selection process please tell us in your application.

How to apply

A PDF (no more than three pages)

or **An audio** or **video** file (no more than 5 minutes long).

We need to know:

Who you are:

Include your name and contact details (either an email address, a postal address, a telephone number, or all of them)

What you want to do: 250 words

Tell us about the resource you are proposing. What is the knowledge or information you want to share, why is it important or useful, and who might use it? If you anticipate it being published in a specific format, please tell us this too.

Things you have done: 150 words

Tell us how your proposal relates to your own experience, using a recent project as an example. Be as simple and clear as possible. You can also include a CV or a link to your work online if this helps in supporting your application, but we will be looking mainly at your proposed idea rather than measuring your track record.

You should email your application to <u>curator@g39.org</u> with the subject header "Resource[YOUR_NAME]". You will then receive an auto confirmation and a link to a separate, opt-in, equality monitoring form.

If you are submitting your application as an audio or video recording, please email a link; if this is difficult, get in touch. No assessment of the production quality of audio or video recordings will be made.
